**TRUST DEED**  
**VAISH MAHAVIDYALA TRUST, BHIWANI**  
**EXECUTED BY VAISH SABHA, BHIWANI**

Know all men by those present that I Mela Ram adopted son of Lala Nar Singh Dass resident of Bhiwani by caste Vaish by occupation merchant president of Vaish Sabha, Bhiwani declare as follows :-

Whereas the Vaish Sabha, Bhiwani is a registered body registered under section 3 of the Societies Registration Act 1860 and whereas the said Vaish Sabha owns and holds various properties movable and immovable and other funds and assets. And whereas the said properties are at present deemed to be vested in the Governing Body of said Society by virtue of section 5 of the Societies Registration Act and as the General meeting of the said Vaish Sabha by a resolution passed on the 5th of November, 1941 authorised me to create Trust of all the movable and immovable properties assets and liabilities, so that all the movable and immovable properties fund etc. might be vested in trustees in place of the governing body of the said Vaish Sabha as at present. And whereas the said resolution was confirmed by another general meeting held on the 14th March, 1943 and whereas the said Vaish Sabha had decided to create the following trust and to vest the properties both movable and immovable in trustees now these presents witness and I do hereby declare as follows :-

1. I declare that the properties described in the schedule A and B annexed hereunder and II additions and accretions thereto and all other properties money belonging to the said trust (hereinafter referred to as Trust property) shall vest in the trustees upon trust for the proposed and in the manner herein contained.
2. The name of the Trust shall be Vaishya Mahavidyala Trust.
3. The Head office of the trust shall be situated at Bhiwani in the district of Hissar. The trustees shall be entitled to have branch or branches at such place of places as they may decide.
4. The aims and objects of the trust shall be as follows :-
  - a) To propagate education - industrial, commercial, technical and arts amidst the males and females by opening schools, colleges, by publishing and circulating papers and books or by any such other means.
  - b) To organise cultural conferences to give social and economic uplift to all the communities irrespective of caste and creed and to procure unity therein.

Clause 4 (C) ammended as below -

- c) To organise cultural Conferences, to give social and economic up-lift to all the communities irrespective of caste and creed and to procure unity therein.

Trustees shall be : (a) people of any community enjoying good reputation and (b) or not less than 21 years of age (c) who has contributed or shall contribute at least Rs. 1100/- to the fund of the trust or (d) whose educational experience or position in society in such that his being on board of trustees is likely to be beneficial to the trust and who are nominated as under. The following shall be the trustees who shall hold office for life unless they cease to be trustees as hereinafter provided in terms of sub-clauses A,B,C,D, of para no. 9 and which shall clause 5 ammender as below :-

6. Board of trustees shall elect a president, A Vice-President, A secretary and Treasurer from among the trustees and may also elect an accountant' (if necessary) who may or may not be a trustee. The

accountant so nominated shall assist the treasurer in discharging his duties particularly in maintaining the trust accounts who shall held office for three years.

7. The board shall be entitled to elect any respectable person likely to improve the condition or otherwise render help to the Vaish Mahavidyala (Vaish College) as patron or partons.
8. The powers of the trustee shall be :-
  - a) To manage the trust properties and do all acts necessary for the preservation and maintenance thereof.
  - b) To invest the corpus and income of the Trust properties not immediately required for the objects and purpose of the trust.
  - c) To vary the investments from time to time as the trustees may think fit and proper with power to sell or otherwise to deal the purpose of the aims and objects of the trust.
  - d) To compromise, compound, abandon, submit to arbitration or otherwise settle any debt, account, claim or dispute what so-ever relating to the trust properties or any part thereof.
  - e) To open account or accounts whether fixed or current in the name of the trust with any bank or banks.
  - f) To bear or pay general expenses for repairs, taxes and outgoing relating to the trust properties.
  - g) To accept, invite and receive donations or subscriptions whether in cash or in kind from any person or persons whatsoever for promotion of the objects and purposes of the trust.
  - h) To delegate all or any of the powers, authorities and discretion by virtue of the deed conferred on or vested in them to any committee or committees either of some of the trustees or of some of the trustees together with any other person not being trustees whom trustees may select and at any time revoke either wholly or partially the authority so conferred on any such committee.
  - i) To make or frame and from time to repeal or alter schemes, rules, bye-laws and regulations as to the management of the trust properties and of the trust affairs or as to the conduct of business by any committee or management or any committee or sub-committee or as to any of the matters or things within the powers or under the control of the committee of management or any committee of sub-committee.

j) To acquire in the name of the trust or in the name of trustees, build upon, pull down rebuild and to after repair, improve, sell, dispose off or otherwise deal with any land, building or premises for the use or for the object and purposes of the trust.

9. A trustee shall cease to be a trustee and his seat shall be declared vacant on the happening or any of the cases :-

- a) If a trustee continues to neglect for 3 years to the interest of the trust.
- b) If he dies or resigns voluntarily, from the date of his death or in case of resignation from the date of resignation being accepted by the board.
- c) Any trustee may be removed from the Board by 75% of the votes of the total number of trustees constituting the Board if in the opinion of the said 75% majority the continuance of such a person or persons as trustees or trustee shall be harmful to the interest of the board.
- d) If the trustee is convicted of any offence involving moral turpitude.

10. a) Board of trustees shall have an executive committee of eleven or less persons two third of whom shall ordinarily be selected from among the trustees and one third from among the non-trustees. Such Executive Committee will be entrusted with the management of all the institutions connected with the said trust and subject to the general control of the board.

b) The President, Secretary and Treasurer of the board shall be the President, Secretary and Treasurer as well as ex-officio members of the trust executive committee constituted under clause 8H of the trust deed. The accountant (if there is any) shall also be an ex-officio member of the trust executive committee. The office bearers of the board of trustees may or may not be the office bearers of the college and school.

✓ 11. Vacancies in the Executive Committee occurring within the period of three years shall be filled in by the Board of trustees if necessary.

✓ 12. The Executive Committee shall have such powers and authorities as are delegated to it by the board of trustees and the board of trustees shall be entitled to enlarge or curtail the same if and whenever they think fit.

13. General Meeting of Board of trust shall be held at least twice a year.
14. The Board shall elect the first executive committee and the subsequent executive committees will be elected at the end of every third year as soon as possible thereafter. The members of Executive Committee will be eligible for re-election.
15. In all meetings of the trustees 1/4th member of the trustees shall form a quorum. Trustees living away from Bhiwani or from the place of meeting of the board shall be entitled to send their votes in writing to the Secretary of the Board or nominate any one of his co-trustee to vote on his behalf in a particular meeting & the nominee on production of the written proxy shall be entitled to cast vote, in addition to his own.
16. The Principal or Head Master of the Vaish Mahavidyalya as the case may be shall be an ex-officio member of the executive committee but he shall not be entitled to vote at its meeting.
17. All funds of the trust shall be invested in some safe securities and pending investment in securities they shall be deposited in some bank and banks approved for the purpose, after keeping with the treasurer such sum or sums as may be needed for the current expenditure. No funds shall remain in the hands of any trustees.
18. In case of emergency the President of the Board with the consent of at least 3 other Trustees shall be entitled to draw money from the bank or firm in which it is deposited and with like consent deposit the same with any other bank or firm whenever any such action is taken the president shall inform the board of trustees of such action in the very next meeting.
19. All suits on behalf of or against the Board of Trustees shall be brought in and defended by the name of Secretary of Vaish Mahavidyalya Trust, Bhiwani.
20. No member or members of the Board of trustees shall be answerable or liable for any loss arising in the administration or application of the Trust Funds or sum of money or for any damage to or deterioration in any immovable property belonging to the trust, unless such loss, damage or deterioration shall happen by or through is or their defaulter gross and deliberate neglect.





"Supplementary TRUST DEED"

Whereas Trust Deed in the name of Vaish Mahavidyalya Trust was registered at serial No. 231, volume 182 at page 99 to 114 on 29.6.1943 and whereas some amendment have been made in the subsequent meetings of the trust dated 19.10.1975 and 4.12.1977 in order to smoothing working and to bring a trust within the preview of Income Tax Act and whereas aforesaid amendments have not yet been got registered, which are necessary in order to avoid any possible dispute and trustees have authorised Sh. Bhagirath mal, Vice-President of the Trust to get the aforesaid amendments registered vide its resolution No. 9 of the meeting dated 7.5.1992.

Now in pursuance of power vested in me by the said resolution. I Bhagirath Mal S/o Late Sh. Ram Richpal, Vice-president of Vaish Mahayidyala Trust, Bhiwani, hereby declared as follows :-

1. That vide resolution No. 2 of the meeting dated 19.10.1975 of Vaish Mahavidyala Trust, the following amendments were made :-

Trust deed clauses 8 C in original form :

Clauses (8C) to vary investments from time to time as the trustees may think fit and proper with power to sell or otherwise to deal with the corpus, forming trustees estate.

Amended for :

To vary the investments from time to time as the trustees may think fit and proper with power to sell or otherwise to deal with the corpus, forming the trust, estate almost not otherwise than for the purpose and aims and objects of the trust.


Clauses 22 in original form :

In case it is desired to alter, exceed or abridge the purpose of this board of trust for other purposes or amalgamate it either wholly or partially with any other society of institution having objects similar to the objects of the trust, that may be done only by majority of 3/4 votes of the Board of the trustees.

Amended form :


